# Fundraising:

- Brewery Nights continue.
- Spring Fling and Reverse Raffle will be combined into one event on April 22, 2017.
- **Reverse Raffle** is going to be on a larger scale! 1500 tickets will be sold and the grand prize will be \$50,000!!!
- If all 1500 tickets are sold, sports/groups will get \$20 from each ticket sold by the sport/group. It's important to record your sport/group in the space provided on the tickets. ALL 1500 tickets must be sold for sports/groups to get this benefit.
- All tickets must be turned in by March 1, 2017.
- The most tickets sold by individuals will receive a cash prize. Name of seller should be recorded on the back of the ticket stub. First prize is \$750, second prize is \$500 and third prize is \$250.
- Groups/sports will be given the opportunity again to reserve spaces at the Spring Fling for FREE. Two spaces may be reserved at first, if more are available later, we will offer them up to NHS first. Forms to reserve spots were handed out and they are also available online.
- The email address on forms should be used to communicate info pertaining to the event.

- Vendors will not be allowed to breakdown until the Reverse Raffle is over. They can close up and walk their goods out, but no cars/trucks will be allowed to drive into event space while the Raffle is taking place.
- BFAA will not arrange inflatables this year. Bernie Griffin can be contacted if anyone is interested in obtaining inflatables for the event at (919)201-2468.
- Any sport/group that hosts a food vendor will require the vendor to donate 50% of profit if the vendor wants to be on the NHSBFAA food permit for the event.
- If a sport/group hosts a food vendor that doesn't agree to 50% of profit, they will need to obtain their own permit for the event. Permits must be obtained at least 30 days prior to event from Lisa Morgan.

# Webmaster:

- Frances went over the number of spaces for the event. We hosted 41 vendors last year, this year we hope to host 100.
